Terms and conditions

1. Photo Work

- a) Must be photo-based work, inclusive of all types of analogue and/or digital photography work.
- b) Work may be exhibited in prints on any medium.
- c) All photo exhibits must be the original work of the photographer/exhibitor.
- d) By submitting to this exhibition, the photographer/exhibitor acknowledges that the photographs do not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim or interest in the photograph.
- e) All photo work must be securely attached to the panel board with masking tapes or hang by hook/chain. Nails, rivets, staples, screws and double-sided tapes are not allowed.
- f) The exhibitor is required to set-up and display own photo work.

2. Exhibitor move-in period

- a) 06-October 2016 from 3pm – 9pm
- b) The exhibitor is responsible to move-in and install all the photo work.

3. Dismantling

- a) 09-October 2016 from 9pm – 10pm
- b) The exhibitor is responsible to dismantle and remove own photo work.

4. General

- a) The organiser reserves the right to exclude or withdraw from the contest any work that is deemed inappropriate in content or that, for any reason, display of the image exposes the organiser to risk of legal proceedings.
- b) The exhibitor is fully responsible for own photo/art work and personal belongings.
- c) Promotional activities may be conducted only within respective booth.
- d) The exhibitor is allowed to establish new business contacts, contracts and promotions related to photography services. The exhibitor is not allowed to sell travel services and photography trips in this exhibition category.
- e) Exhibitor pass will be issued on the morning of 07-October 2016 from 8:45am.
